Netgsm is a Telecommunication Operator and Value-Added Services provider to its subscribers in Türkiye through its telecommunication infrastructure.

Netgsm has different licences and services; Full Mobile Virtual Network Operator (Full MVNO), Fixed Telephony Services (VoIP Operator), SMS Operator, Internet Service Provider (ISP), Fiber Infrastructure Installation and Operation Services, Data Center Installation and Operation, Internet of Things (IoT) is a Telecom Operator engaged in the operation of services provided over the Cloud, Cyber Security Service Management and Operations for Value Added Services.

R&D Services: Netgsm develops core network software for the telecom sector, infrastructure software for IoT systems, software related to R&D activities for various value-added services, electronic circuits and technological products. It offers the products it has developed to end users (Subscribers).

As a Telecom Operator; Turkcell, Vodafone and Turk Telekom, the Mobile Network Operator (MNO) in Türkiye, provide redundant Voice and SMS at different locations, Türk Telekom and Voice, the Local Fixed Operator, provide direct interconnection to Voice service with the 10 VoIP operators with the most subscriptions. It also has an interconnection with Turkcell, Vodafone and Turk Telekom for direct International Voice access (required by Telecommunication regulation in Türkiye). Netgsm has own 2 data centers with the standards.

In conclusion; Netgsm ranks 3rd (Third) in Türkiye with 100,000+ VoIP subscribers, and 2nd (Second) in Türkiye with 100,000+ SMS subscribers.

NETGSM is Türkiye's first and only full MVNO. It started services to mobile subscribers in March 2023. In Turkiye, Netgsm uses Turkcell base stations together, and its other infrastructure belongs to it. NETGSM; It has set up its infrastructure so that 1 million subscribers, which is around 1% of the 90 million mobile subscribers owned by 3 mobile operators in Türkiye, will be transferred to itself by the end of 2023. No mobile numbers other than 3 Mobile Operators have been given in Türkiye for around 30 years, and it is the first time that a mobile number can be obtained from a 4th operator or that a mobile number can be transferred to a 4th operator; It makes it easier for NETGSM to exceed 1 million subscribers by the end of 2023.

Within the scope of Internet Service Provider (ISP) authorization, it started to provide Internet Subscription services via Wireless Solutions and Türk Telekom, a Local Fixed Operator.

Within the scope of **Telecom Infrastructure Provider Authorization**, fiber cables are installed in various regions of Türkive.

As Value Added Services; NETGSM, IP-PBX (Fixed Line IP Softswitch) that works over the Internet, developed by R&D, used by 10.000+ corporate companies. Unified communication-based CRM software in which all communication platforms used by 1000+ corporate companies are integrated. Internet cloud-based and mobile application used by 1000+ corporate companies loT subscribers offer. Cloud-based and mobile-applied

Personnel Attendance Control Services used by 1000+corporate companies as Value-Added Services. Integration connections have been established with SMS - Voice - MVNO applications provided by NETGSM, Cloud IP Softswitch - Unified Communications CRM for thousands of national and international application software created in over 10 years.
